

Trailing P/E is the weighted average ratio of closing price to trailing 12-month market convention earnings per share as of the date of analysis. Trailing P/C is the weighted average ratio of closing price to trailing 12-month market convention earnings per share as of the date of analysis. Trailing P/B is the weighted average ratio of closing price to book value per share as of the date of analysis. Trailing EV/S is the weighted average ratio of the enterprise value to trailing 12-month sales as of the date of analysis. Small-Cap = less than \$2 billion, Mid-Cap = \$2 billion, -\$10 billion, Large-Cap = greater than \$10 billion.
